**Narragansett Indian Tribe
Camping Permit & Regulations
August Meeting 2022**

1. **Camping permit and regulations for the 347TH August Meeting, Powwow will be issued by the Assistant Director Steven Smith of The Natural Resources/Tribal Planning office at (401) 364-1100 x 205. Tribal members must provide their Tribal Identification number/ID.**
2. **Non-Tribal members will be charged a \$25 fee for the entire powwow/camping weekend.**
3. **Camping will be allowed on Powwow Grounds as well as the "Designated Camping Area.**
4. **Vendors must obtain a camping permit.**
5. **Camping Permits will only be issued to Powwow Participants 18 years or older.**

6. The Tribal member to whom a camping permit is granted shall be an occupant of the campsite, shall state the first and last names of members of the party--Tribal/Non-Tribal, and shall be responsible for his or her party's compliance with the camping regulations. Non-Tribal members shall not remain at the site if the permitted Tribal member has vacated the camp.
7. No more than two motor vehicles shall be allowed for parking.
8. The Permittee will receive a Camping Pass which must be placed on the dashboard of his/her vehicle during the entire stay.
9. The above-named party shall be held responsible for damages, liability, conduct and actions of all members of the campsite and guests. The permittee is responsible for trash found at the campsite directly after the party vacates the campsite. The occupants of the campsite must remove all trash and other items. Violators shall be subject to a fine up to \$500 and may lose camping rights.
10. **NO FIREARMS ALLOWED on the grounds at any time. Any violators will be subject for arrest and prosecuted. Any further permits may be denied.**
11. **NO ALL-TERRAINE VEHICLES (ATV) ALLOWED on the grounds at any time. (Any violations will result in the confiscation of the ATV by Tribal Law Enforcement Personnel).**
12. **No Dogs allow except Service Animals.**
13. No person shall cut, remove, or damage any tree, shrub, or vegetation.
14. All campfires must be contained and monitored by adults at all times. Campfires must be away from any vegetation and tents. No fire shall be left unattended. Campfires must be totally extinguished before breaking camp or retiring for the evening.
15. **No person shall sell or offer for sale any intoxicating beverages. Public drunkenness shall be grounds for removal. Any person found to be in possession of illegal drugs would be arrested. All persons/campsites are subject to search for illegal contraband from Tribal Law Enforcement Officers upon probable cause. Any violators will be removed. Any further permits may be denied.**
16. No person shall refuse or neglect to obey the direction of any Tribal Law Enforcement Personnel at any time.
17. In addition to the above-enumerated regulations, all regulations applicable to the Tribal lands are in full force and effect.
18. The permitted party shall be limited to the activity so stated above. Any deviation of the stated activity noted, shall be in violation of the camping regulations and due cause for the revocation of this period. Violations to these camping regulations may result in a loss of camping rights. The Tribal Council/Tribal Court must hear all violations.
19. The Narragansett Indian Tribe will not be held responsible for any theft or injuries, or accidental death or other liabilities incurred during the period indicated above.
20. **Other than for medical or handicap purposes, no animals will be allowed at campsites.**
21. If the permitted party finds cause or reason that may change his/her original conducts of the stated activity, they must seek further express permission for such purpose from the Chief Sachem/Tribal Council.
22. **Do to tribal and public safety, The Tribal Police and Environmental Police Department will enforce a Curfew of 12:00AM. Participants will not be allowed to leave nor be able to come on the tribal grounds unless of an emergency.**
